SDDA Endorses Avera Health Plans

he South Dakota Dental Association, through Professional Insurors, has endorsed Avera Health Plans as the first step in a goal of creating an SDDA association health plan.



"Avera received the endorsement because it has both competitive pricing and a statewide network of providers. The Avera regional pricing methodology will allow for a variance in price from one area of the state to another, but overall that endorsement will provide an opportunity for most member to save money on health insurance.

The SDDA's long-range goal is to have its own association health plan and this is clearing the biggest hurdle towards that goal, according to Paul Knecht, the SDDA Executive Director. "Due to some requirements within the law and the current utilization rate of our members, an association health plan is not feasible for us at this time. We believe a partnership with Avera Health Plans through Professional Insurors will move us in that direction."

"If enough of our members subscribe to the Avera plan, this endorsement will turn into the creation of a fully-insured SDDA association health plan," Knecht continued. "At that point, all of our members will be able to realize a savings through the collective purchasing power of the association."

Stressful Times Can Take A Toll

If you, or someone you know, needs help because of the added stress created by the COVID-19 crises, or if you are suffering from alcohol or drug abuse, help is available. Dentists and allied staff members in South Dakota have access to services from two sources.

Community Mental Health Centers in South Dakota

SDDA members can access counseling services through any of the Community Mental Health Centers in the state through a relationship between the SDDA and the South Dakota Council of Community Behavioral Health. Community mental health centers are located in communities throughout the state. These centers provide professional outpatient counseling and related services to the general public, as well as specific assistance for the business, legal and health care communities including dentists and allied dental staff. For a listing of Community Mental Health Centers in South Dakota go to the Member Center of the SDDA web site and click on Member Wellness. Under an agreement with the Council of Community Behavioral Health the SDDA will cover the cost of the initial consultation for any member dentist; non-member dentist; and, SDDA allied member who lacks the resources to pay for their care.

Health Professionals Assistance Program

All licensees of the South Dakota State Board of Dentistry may seek participation in the South Dakota Health Professionals Assistance Program (HPAP). Voluntary self-referrals are accepted. This confidential program is professionally staffed and designed to monitor the treatment and continuing care of regulated health professionals who may be unable to practice with reasonable skill and safety, if their illness of chemical dependency is not appropriately managed. The program provides a non-disciplinary option for participating health licensing boards to deal with impaired regulated health professionals who recognize their illness and the need for continuing care and/or practice limitations. Services include general outreach, crisis intervention, informal assessment, treatment monitoring, and support for providers who need our assistance.

The South Dakota HPAP is dedicated to enhancing public safety and support for regulated health care professionals by facilitating the early intervention, treatment, continued care, and monitoring the safe return to practice for regulated health professionals who may be unable to practice with reasonable skill and safety if their mental health or substance use illness symptoms are not adequately managed.

In addition to self-referrals, HPAP encourages referrals from families or peers, or referrals from medical or treatment agencies. Calls to HPAP about a colleague are held in the strictest confidence and HPAP can serve as a resource to help determine appropriate next steps.

The St. Francis Mission Dental Clinic closed our doors March 16th, 2020. Due to the extreme vulnerability of our community members we acted swiftly and prudently in cancelling our scheduled clinics through the Summer of 2020. Our thanks to all the dentists and hygienists (for understanding our shut down) who had planned on volunteering and set aside time in their schedules to provide services at our clinic.

Our goal is to plan and coordinate an emergency clinic by August of 2020. Our first tentative clinic will be with Remote Area Medical (RAM), August 14-16. Traditionally, RAM has set up portable dental chairs in another building on campus, but this year we are attempting to have our dental volunteers work out of our dental clinic. Prior to reopening we are working to obtain the necessary PPE and do some renovations to our clinic to accommodate a new screening and intake area.

COVID-19 Impacts Dentistry in South Dakota

F or a period of four to six weeks this spring most of the dental offices in South Dakota were treating only patients with urgent and emergent needs. During that same time office staff were temporarily furloughed and many sought financial relief by going on unemployment and practice owners applied for relief from one, or more, Federal programs. Offices were closed as a result of both Federal and State directives aimed at slowing down the spread of the coronavirus in South Dakota. The lifting of the Governor's executive order, in early May, saw many offices returning to practice, but with a host of new protocols in place to protect patients and staff from spreading the virus. The scarcity of personal protective equipment (PPE) created a major obstacle as many offices could not get PPE through their normal suppliers.

Throughout the confusion and frustration of complying with Federal recommendations and State requirements the American Dental Association (ADA) and the South Dakota Dental Association (SDDA) used electronic communication to keep members abreast of the ever-changing situation and the most appropriate methods to function in a new and uncertain environment.

The full impact of several weeks of office closure, and untreated dental needs will not be fully known from sometime, if ever. However, what can be learned from a crisis that evolved as quickly as the COVID crisis did, is that access to timely and reliable information is critical to decision making for every dental practice. Members are encouraged to continue to watch for ongoing updates from both the ADA and the SDDA and to visit the websites of both organizations for reliable advice and guidance on dealing with COVID-19.
